
















"I believe that I'm mentally and physically healthier when the natural environment around me is healthy."

9. On a scale of 1-5, how would you rate these environmental health aspects of forests and green spaces within your community?











14. On a scale of 1-5, how likely are you to adopt any of the above environmental conservation and restoration practices **on your property** if they were to improve your community's environmental health?



"I believe that soil and water contamination on neighboring properties decreases the property value of my land."


